## Introduction

edison365 (the 'Company') recognizes the importance of environmental protection, and is committed to operating its business responsibly, and in fulfilment of compliance obligations. The Company declare to operate, and to maintain good relations, with relevant regulatory bodies. The Company will carry out all necessary activities to protect the environment.

The Policy is regularly reviewed to ensure its continuing suitability.

This Policy provides a set of environmental principles that direct its actions and responsibilities.

### Scope

This Environmental Policy is applicable to all edison365 employees, suppliers, and contractors. All edison365 third parties must comply with their contractual obligations to edison365 and follow the principles in this Policy.

### Statement

edison365 take its impact on the environment seriously. edison365 ensures that in every location where it operates and for any goods and services edison365 purchases, edison365 does all that it can to adopt sustainable practices and reduce and mitigate its environmental impact and those of its customers, in compliance with local, regional, and international laws, standards, and frameworks.

## Policy

### Managing Objectives

edison365 environmental objectives are set out in the Risks, Aspects, Objectives and Opportunities Register. Within this register, edison365 identifies any opportunities and risks to environmental management. This register is reviewed at least bi-annually or at any time where risks need to be monitored.

### Commitment

edison365 are committed to becoming carbon neutral by 2025. This will be monitored in line with the Environmental Objectives register with the Environmental Aspects and Impacts Register.

## Management Responsibilities

The edison365 management team demonstrates leadership and commitment by:

- Taking accountability for the effectiveness of the Management System.
- Ensuring that the Environmental Policy and Environmental Objectives are established and are compatible with the strategic direction and the context of edison365.
- Ensuring the integration of the Management System requirements into the business processes.
- Ensuring that the resources needed for the Management System are available.
- Communicating the importance of effective environmental management and of conforming to the Management System requirements.
- Ensuring that the Management System achieves its intended outcomes.
- Directing and supporting persons to contribute to the effectiveness of the Management System.
- Promoting continual improvement.
- Supporting other relevant management roles to demonstrate their leadership as it applies to their areas of responsibility.

## Continuous Improvement

The Company will continuously improve by:

- Regularly reassessing the environmental effects of edison365's activities.
- Ensuring the Company's legal duties, statutory obligations, internal policies, and procedures are always complied with through monitoring and audits.
- Training of employees in environmental issues.
- Minimize the production of waste.
- Minimize material wastage.
- Minimize energy wastage.
- Promote the use of recyclable and renewable materials both as a Company and individuals.
- Prevent pollution in all its forms.
- Minimize the risk to the general public and employees from operations and activities undertaken by edison365.

## Compliance

All edison365 employees, contractors, suppliers and any other third parties who conduct business with or on behalf of edison365 must always comply with the applicable environmental legislation. This includes international, national, or local laws and international standards related to its business operations, products, or processes.

## Communication
